



## WINTER 2025 – BRING IN NEW MEMBERS PROMOTION – OFFICIAL RULES

Register yourself for a Winter 2025 lecture series and bring about other registrations for a Winter 2025 lecture series by **TWO NEW REGISTRANTS** and you will receive one **FREE** registration for our Fall 2025 session. New Registrants may include a former member only if they have not registered for a lecture series since Winter 2020. The promotion is open for the full Winter 2025 registration period.

### Eligibility

1. To be eligible you must have registered for one or more of our Winter 2025 lecture series and arranged for two (2) “new” people you have persuaded to register for a Winter 2025 lecture series to enter your name and email address in the designated space on their registration form at the time they register, identifying you as the Referring Party.
2. A “new” registrant is a person who:
  - a. registers for a Winter 2025 lecture series, and
  - b. has never registered for a Learning Unlimited Etobicoke lecture series, or
  - c. was a previous attendee who has not registered since Winter 2020.
3. A “Referring Party” is the person who a “new” registrant confirms on their registration page at the time of registering is the person who persuaded them to register.
4. You may win up to two (2) free registrations on the basis of one free registration for each two (2) ‘new’ registrants introduced. Three ‘new’ registrants only gives eligibility for one (1) free Winter 2025 registration
5. The promotion is open during the full registration period of Winter 2025 which will close on February 6, 2025.
6. Should either the original registrant or one of the ‘new’ registrants cancel prior to the start of the lectures, the eligibility is voided.

### Nature of the Prize

7. We will thank you by providing you with free registration to one of our Fall 2025 lecture series which will begin the week after Thanksgiving. You may choose which of the Fall 2025 lecture series you prefer to attend.

8. The free Winter 2025 prize cannot be cancelled for a refund, will have no cash value and must be accepted in the form of a free registration.
9. The free registration cannot be changed for a different lecture series after the first day of the lecture series.
10. The prize is not transferable.

#### Method of Selection

11. We will first verify your own registration in our records.
12. We will compare the names of “new” registrants who entered referral information at the time of registration to our database records to determine their eligibility as being either not previously registered or not registered since Winter 2020.
13. We will compile the list of names cited as being the Referring Party and establish that there are two “new” registrants (or more) for each Referring Party.
14. Where we are satisfied that a Referring Party has provided four (4) eligible “new” registrants, we will award a second prize.

#### Notification Date

15. We will prepare our final list of eligible promotion winners by February 18, 2025 and notify you using the email address you have provided to us. This date is one week in advance of the opening of registration for our Fall 2025 series.
16. We will remind you during the lectures in the week of February 18 that prize winners have been notified. 17. A list of prize winners showing only first name and last 3 digits of postal code will be posted on our website following the notification date.

#### Dispute Resolution

18. Should a “new” registrant cancel and re-register, the referral information provided on the initial registration will stand.

#### Exclusions

19. No member of the Board of Learning Unlimited Etobicoke or their immediate family members will be eligible for the promotion.
20. Non-Board member volunteers involved in the organization/administration of the promotion will not be eligible for the promotion.

#### Authority

21. The decision of the Board of Directors, led by Ms. Forsyth-Petrov will be final.
